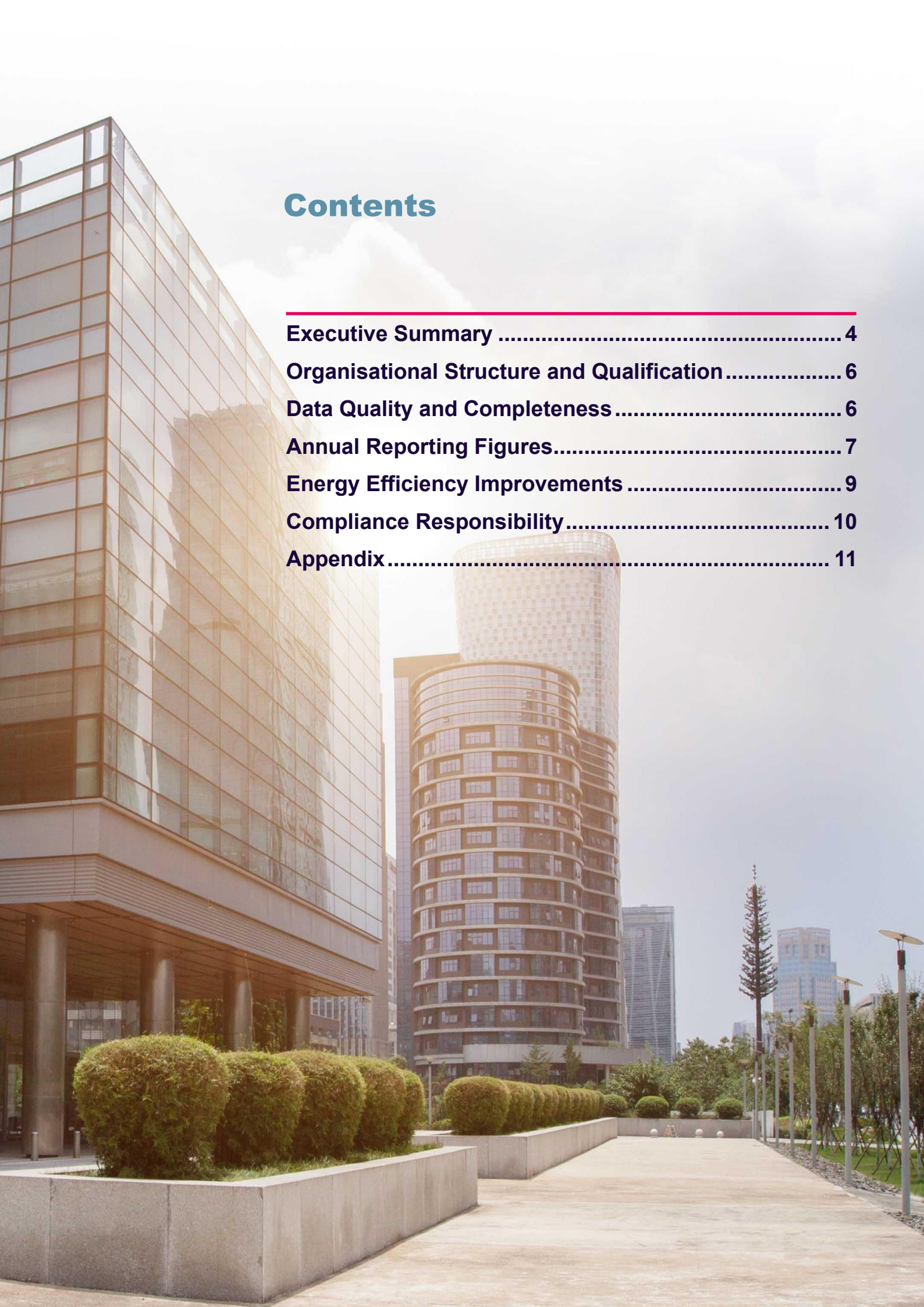

It also summarises, in the appendix, the methodologies utilised for all calculations related to the elements reported under Energy & Carbon.

Two entities within the Genius Sports group family are deemed large UK incorporated business under the Companies Act 2016.

Accordingly, this SECR Report is provided on behalf of Genius Sports UK Limited 04062777 and Genius Sports Technologies Limited 10197219, Genius Sports Group Limited 09706742, and their related entities (collectively “Genius Sports” or the “Group”) to comply with the mandate for large entities to provide energy consumption, emissions, intensity metrics and all energy efficiency improvements for the most recent financial year. This SECR Report is incorporated, by this reference, to the 2021 Directors Report for Genius Sports Technology Limited and Genius Sports Group Limited.

This report covers the collective of our UK operating companies, inclusive of those which are not otherwise required to comply with SECR disclosures on an individual basis. Included within this report of, although not delineated by entity (as explained below), is the consumption data for both group entities: Genius Sports UK Limited and Genius Sports Technologies Limited, who are legally required to comply with SECR disclosures. This report therefore covers UK Scope 1, Scope 2 and Scope 3 emissions, intensity ratio and yearly comparisons on an aggregated basis group basis for the UK operations within the group structure.

This aggregate reporting is provided to account for occurrences where our group entities jointly utilise certain energy consuming resources and in such cases the consumption and emissions are indivisible by entity.

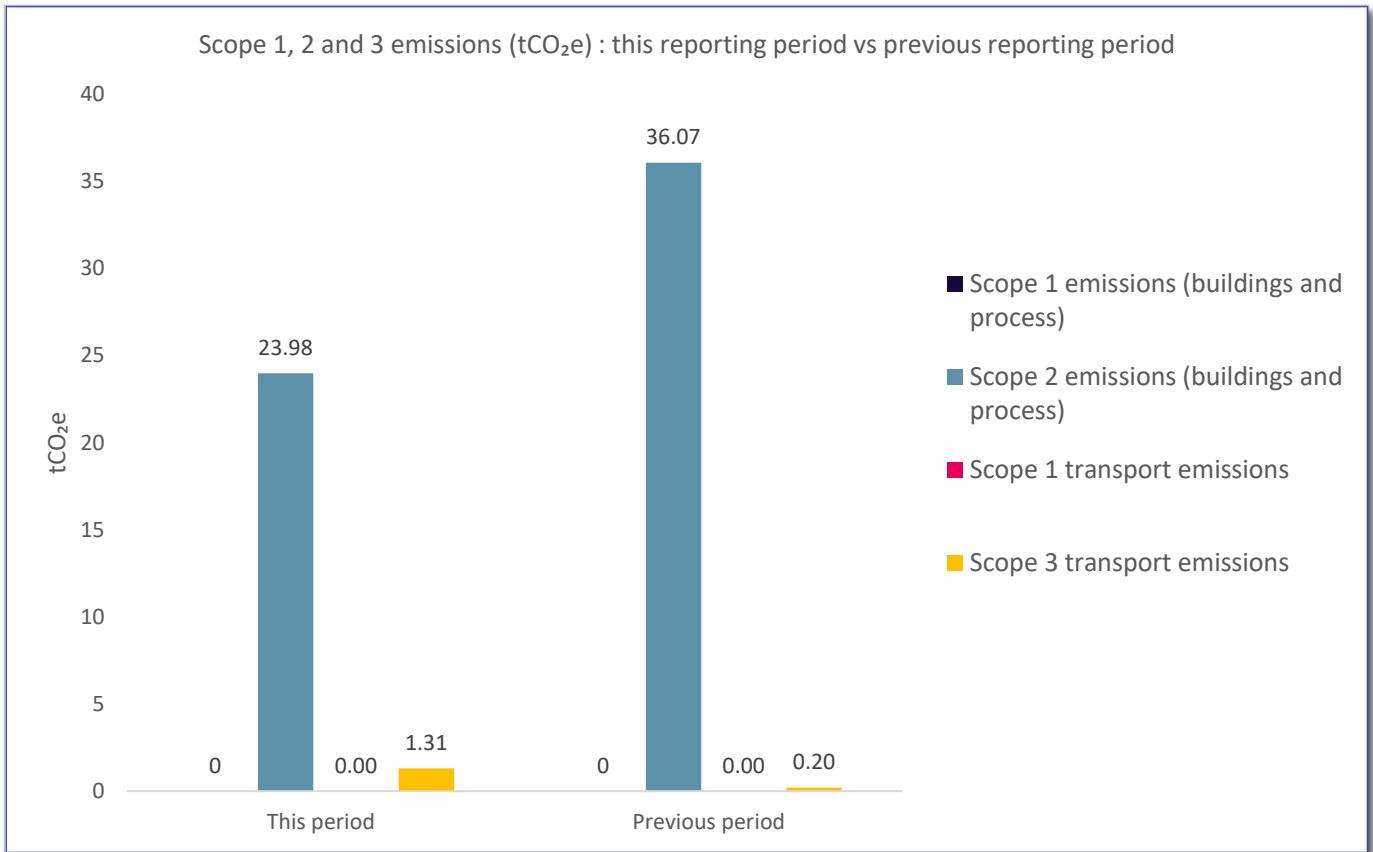
During the reporting period, no other Group entities met the individual entity threshold for SECR reporting. Any references to individual entity consumption and emissions which are detailed in this report are provided for the purpose of transparent and thorough compliance with SECR.

A corporate structure chart for the 2021 Financial Year has been provided with this report to clarify the entity relationships further.

Genius Sports is a leading provider of sophisticated data-driven technology and services that fuel the sports data ecosystem for sports, media and licensed sportsbooks worldwide. During the reporting period Genius Sports Group Limited was the Group parent company.

## Year 2



Genius Sports Group Limited Scope 3 direct emissions (combustion of transportation fuels) for this year of reporting are 1.31 tCO<sub>2</sub>e, resulting from the direct combustion of 5,662 kWh of fuel. This represents a carbon increase of 555% from last year.

Scope 2 indirect emissions (purchased electricity) for this year of reporting are 23.98 tCO<sub>2</sub>e, resulting from the consumption of 112,918 kWh of electricity purchased and consumed in day-to-day business operations. This represents a carbon reduction of 27% from last year.

Our operations have an intensity metric of 0.08 tCO<sub>2</sub>e per FTE for this reporting year.

This represents a reduction in operational carbon intensity of 66% from our previous reporting year.

During the reporting period, Genius Sports Group Limited, a company registered in England, with the registration number 09706742, and its subsidiary entities (collectively “Genius Sports” or the “Group”) are a leading provider of sophisticated data-driven technology and services that fuel the sports data ecosystem for sports, media and licensed sportsbooks worldwide. Genius Sports Group Limited was the Group parent company.

During the reporting period, no other Group entities met the individual entity threshold for SECR reporting. Any references to individual entity consumption and emissions which are detailed in this report are provided for the purpose of transparent and thorough compliance with SECR.

## Data Quality and Completeness

Invoices have been entered into a fully managed energy database up to 31<sup>st</sup> December 2021.

### Data Completeness

All Genius Sports Group Limited’s electricity and gas invoices have been entered into a fully managed energy database up to 31<sup>st</sup> December 2021, and data quality checks have been carried out for data completeness and accuracy. All transport information has also been entered into the energy database up to 31<sup>st</sup> December 2021.

There were a number of instances, equating to 6% of the total reported consumption, where it was necessary to calculate some estimated consumption to achieve 100% data coverage. Methodology of these estimation techniques is detailed in the appendix.

## Consumption (kWh) and Greenhouse Gas emissions (tCO<sub>2</sub>e) Totals

The following figures show the consumption and associated emissions for this reporting year for our operations, with figures from the previous reporting period included for comparison.

Scope 2 consumption and emissions relate to indirect emissions relating to the consumption of purchased electricity in day-to-day business operations.

Scope 3 consumption and emissions relate to emissions resulting from sources not directly owned by us. This relates to grey fleet (business travel undertaken in employee-owned vehicles) only.

An intensity metric of tCO<sub>2</sub>e per FTE has been applied for our annual total emissions. The methodology of the intensity metric calculations are detailed in the appendix, and results of this analysis is as follows:

# Energy Efficiency Improvements

Genius Sports Group Limited are committed to year-on-year improvements in their operational energy efficiency.



---

## Energy Efficiency Improvements

- We manage our office space more efficiently through the use of shared spaces and hot desking, so that the total square footage is used more efficiently, and less space is needed per person. This is done with space management software.
- We have completed a review of office and data centre energy suppliers to see where we can incorporate renewable energy.
- We have a carbon reporting dashboard for our rail, air and other travel.
- Automatic lighting has been implemented in our offices and ensure in designs that we are optimising use of natural light.
- We have desktop sleep function and the same for printer, AV/TV/VC and shared equipment power-off
- We ensured a shutdown of offices that have been fully closed for any period of the pandemic, e.g. HVAC systems
- We implemented an essential-only travel reduction
- A ‘resources awareness month’ was held, encouraging reduced elevator use and green commuting this included vouchers for e-bikes, discounts for cycle shops and cycle-to-work schemes.
- Regular planned preventive maintenance is undertaken on HVAC units and windows to help identify energy leakages and give insight into equipment performance.

## Reporting Methodology

Scope 1, 2 and 3 consumption and CO<sub>2</sub>e emissions data has been calculated in line with the 2019 UK Government environmental reporting guidance. Emissions Factor Database 2021 version 1 has been used, utilising the published kWh gross calorific value (CV) and kgCO<sub>2</sub>e emissions factors relevant for reporting period 01/01/2021 – 31/12/2021.

Estimations undertaken to cover missing billing periods for properties directly invoiced to Genius Sports Group Limited were calculated on a kWh/day pro-rata basis at meter level. These estimations equated to 6% of reported consumption.

Intensity metrics have been calculated using total tCO<sub>2</sub>e figures and the selected performance indicator agreed with Genius Sports Group Limited for the relevant report period:

- Full time equivalents (FTE) **327.7**
